INDIVIDUALS AND PACS WITHOUT MEGA PAC STATUS MAY CONTRIBUTE UP TO \$5,500 PER ELECTION CYCLE. PACS WITH MEGA PAC STATUS MAY CONTRIBUTE UP TO \$11,000 PER ELECTION CYCLE. CONTRIBUTIONS FROM CORPORATIONS, LLCs, LABOR UNIONS, AND FOREIGN NATIONALS WITHOUT GREEN CARDS ARE PROHIBITED. ARIZONA LAW REQUIRES BIGGS FOR ARIZONA TO REQUEST IDENTIFYING INFORMATION FROM EACH CONTRIBUTOR, AND TO MAKE ITS BEST EFFORTS TO COLLECT AND REPORT THE NAME, ADDRESS, OCCUPATION AND EMPLOYER OF ALL OUT-OF-STATE INDIVIDUAL CONTRIBUTORS AND OF ARIZONA RESIDENTS WHO CONTRIBUTE MORE THAN \$100 DURING AN ELECTION CYCLE.
